DESCRIPTION

Prominent period 3-storey corner building, a former public house now trading as a convenience store arranged over the ground floor with a rear yard for deliveries and customer car parking.

The first and second floors comprises a 1 x 1 bedroom flat, a 1 x 2 bedroom flat and a 1 x 3 bedroom flat, with self-contained access from Selhurst New Road.

LOCATION

The property is situated on Selhurst Road (A213), on the corner of Selhurst New Road and between Gloucester Road in Selhurst, South London.

Neighbouring occupiers include The Brit School, Crystal Palace Football Club, Selhurst Medical Centre, Selhurst Train Depot, Pauline Quirke Academy of Performing Arts, Selhurst Sports Arena, Jones Building Supplies and Selhurst Timber, together with a good mix of other independent and local traders.

Selhurst mainline railway station is within walking distance, providing services to London Victoria, London Bridge, Epsom, Caterham, Portsmouth, East Grinstead, Bognor Regis and Littlehampton. There are also buses serving the area located on Selhurst Road.
